We launched our Made to Belong Trauma Curriculum for Faith leaders and 497 leaders, parents, and volunteers gained understanding and practical application. We were excited that throughout these spheres 505 volunteers donated 2027 hours to make a difference with our I Belong Project™, Dream Makers Project, fund raising events, faith sphere events, and through administrative assistance.

One of America's Kids Belong signature programs is the I Belong Project™. With the help of the creative community, the I Belong Project™ is telling stories. By giving these kids and sibling groups a face and a voice, we give them a better chance--a 9x better chance--of being seen, receiving an inquiry and being adopted. In 2020 with safety measures implemented in response to COVID, we had 28 days of filming with 183 kids legally free for adoption.
